

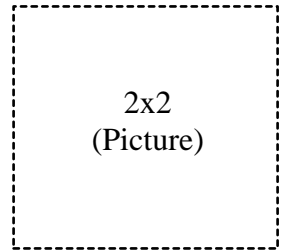

INSTRUCTIONS

1. Fill up application form properly to avoid delays.
2. Submit to respective Admin/Security Officers the duly accomplished application form with the following attachments
 - a) Photocopy Official Receipt (OR);
 - b) Photocopy of Certificate of Registration (CR);
 - c) Photocopy Deed of Sale, if not yet transferred in the name of the applicant;
 - d) Certification from the registered owner authorizing the applicant to use the vehicle of the former (for vehicle/motorcycle under the name of the company/business entity);
 - e) One 2x2 picture each of the registered owner and authorized driver;
 - f) Photocopy of valid ID or Driver's license (for civilian); and
 - g) Photocopy of PNP ID (For Type "A" and "B").
3. Application forms shall be endorsed by respective Admin/Security Officers.
4. Liaison Officer to submit the accomplished form to IID, HSS for issuance of Order Slip. The Official Receipt shall be submitted to IID upon payment.
5. Authorized representative to pick-up the passcard/decal on the day indicated in the claim stub.
6. Civilian (Type "C") applicant must be sponsored/endorsed by an active Police Commissioned Officer (PCO). (Attach photocopy of sponsor's/endorser's PNP ID)
7. Vehicle Access Passcard/ Decal is not an exemption from security inspection imposed by security personnel of the camp.
8. Passcard/Decals access are valid only for one year.
9. Passcard/Decals access are only authorized on the following schedule:

Gates 1 & 3:	5:00 AM to 8:00 PM (Monday to Friday)
Gate 2:	24 hours a day
