CONTRACT

TO SUPPLY 160 UNITS OF HF/SSB BASE RADIO
UNDER PUBLIC BIDDING NO. PNP-17-17G

THIS CONTRACT, made this 13 SEP 2017, 2017 by and between:

PHILIPPINE NATIONAL POLICE, a law enforcement agency of national government created and existing by virtue of and pursuant to RA No. 6975, as amended by RA No. 8551, its National Headquarters located at Camp Crame, Quezon City, represented by the Chief, Philippine National Police, POLICE DIRECTOR GENERAL RONALD M DELA ROSA, herein referred to as the "Procuring Entity";

-and-

SCAN MARINE INC. a duly registered business entity pursuant to Act 3883, as amended by Act 4147 and Republic Act No. 863 with office address at 160 Honorio Lopez Blvd., Balut Tondo, Manila represented by MR. NELSON D. PEÑAREDONDO, herein referred to as the "Supplier".

WHEREAS, Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of 160 units HF/SSB Base Radio under Public Bidding No. PNP-17-17G** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Seventy-Five Million Nine Hundred Fifty-Seven Thousand Six Hundred Pesos (Php75,957,600.00)** (hereinafter called "the Contract Price").

NOW THIS CONTRACT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.



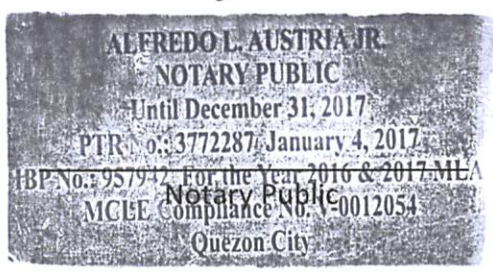

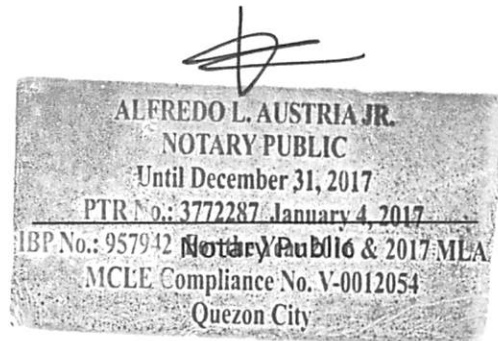
