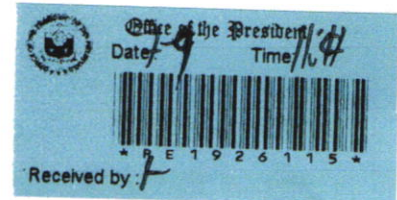

Attached are the complete list of names for Third Level PCOs and their corresponding Network for your ready reference.

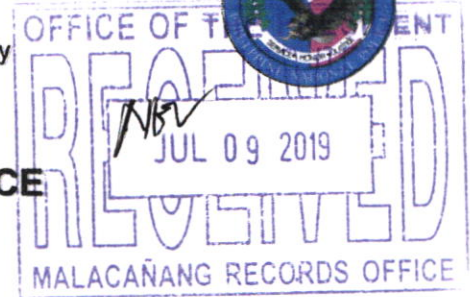
