The Philippine National Police, with the General Appropriations Act of 2020 as basis, intends to apply the sum stated below being the Approved Budget for the Contract (ABC), hereby notifies the above invited proponents, to negotiate for the herein contract through **Alternative Method of Procurement (Negotiated Procurement) – Two Failed Biddings.**

Please be informed that your firm is among the invited proponents to participate in the project.

Furthermore, please be advised that **ALL interested proponents** that are legally and technically capable to join the herein procurement project can also participate in the Negotiated Procurement.

The **Negotiated Procurement** will be conducted pursuant to Section 53.2 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 under **Emergency Cases**, and in accordance with **Item V (D)(1)(a)** of Annex "H" thereof, stating that "**Negotiated Procurement is a method of procurement of Goods, Infrastructure Projects and Consulting Services, whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant in any of the following cases: 1. Two Failed Biddings.** A) Definition. Where there has been failure of competitive bidding or Limited Source Bidding for the second time as provided for in Section 35 of RA 9184 and its IRR, when: Xxx xxx xxx; iii. All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of consulting services, there is no successful negotiation."

In this regard, please be advised of the requirement under Annex "H" Item V (D)(1)(b)(iv) stating that "Following completion of the negotiations, the BAC shall

request all suppliers, contractors, or **consultants** in the proceedings to submit, on a specified date, a **best offer based on the final technical and financial requirements**. Pursuant to Section IV(G) of this Guidelines, the Procuring Entity shall require the submission of a Certificate of PhilGEPS Registration in accordance with Section 8.5.2 of the IRR of RA 9184.”

To negotiate for this procurement, the prospective supplier is required to submit **one (1) ORIGINAL and one (1) COPY** of the **Eligibility Documents**, **Technical Documents**, and **Financial Documents** of its proposal.

A supplier that submits a Proposal will be considered and recommended for Evaluation. If found compliant and capable in accordance with the requirements of the law and the PNP as stated hereto, said proponent will be recommended to the Head of Procuring Entity for the issuance of Notice of Award.

Specific instructions, conditions and requirements in the conduct of negotiation and contract implementation shall be those as indicated in the preceding parts/sections.

Proposals will be opened in the presence of the proponents’ representatives who choose to attend at the address above. Late proposals shall not be accepted.
