

# CONTRACT

## CONSULTING SERVICES FOR ISO CERTIFICATION OF VARIOUS PNP UNITS UNDER PUBLIC BIDDING NO. PNP-18-01CS

THIS CONTRACT, made this 27 February 2019 by and between:

**PHILIPPINE NATIONAL POLICE**, a law enforcement agency of national government created and existing by virtue of and pursuant to RA No. 6975, as amended by RA No. 8551, its National Headquarters located at Camp BGen Rafael T Crame, Quezon City, represented by the Chief, Philippine National Police, POLICE DIRECTOR GENERAL OSCAR D ALBAYALDE, herein referred to as the "Entity";

-and-

**TUV RHEINLAND PHILIPPINES, INC.**, a duly registered business entity pursuant to Act 3883, as amended by Act 4147 and Republic Act No. 863 with office address at G/F La Fuerza Building 1, 2241 Don Chino Roces Avenue, Makati City, represented by MR. TRISTAN ARWEN G. LOVERES, herein referred to as the "Consultant".

**WHEREAS**, Entity is desirous that the Consultant execute the **Consulting Services for ISO Certification of Various PNP Units under Public Bidding No. PNP-18-01CS**, hereinafter called "the Works" and the Entity has accepted the Bid for **Two Million Seven Hundred Thousand Pesos [Php2,700,000.00]** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- Annex G - Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;



- Annex H - Eligibility requirements, documents and/or statements;
- Annex I - Performance Security;
- Annex J - Notice of Award of Contract and the Bidder's conforme thereto; and
- Annex K - Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.




